Articles to raise awareness about lesser-known heritage sites:

Provision of oil and ghee to light lamps in temples with low patronage



Due to lack of patronage, several temples struggle to keep the premises adequately lit. In order to overcome this basic constraint, Aalayam Kanden Trust, through patronage of its members has been providing five litres of ghee and oil to these temples wherever possible. During this financial year, oil and ghee was provided to the Chinna Mandali Niranjeeswarar Temple.



Support to temples



Muthuservamadam is a non-descript village near Gangaikonda Cholapuram. The village has very little tourist footfall or patronage. The beautiful Varadaraja Perumal temple here is being renovated through the hard efforts of the villagers. To provide a fillip to the activities, the Aalayam Kanden team visited the temple and documented the same. Rs. 5000 was paid

towards the construction expenses

from the

personal funds of the team members.

The Naganatha swamy temple in Thirukuvalai, Nagapattinam District did not have dolls to make a Kolu in the temple. Aalayam Kanden Trust sourced the Kolu dolls from its members and transported the same to the temple through the efforts of its volunteer, Mr V R Kaushik, to enable the temple to celebrate its Navaratri festival.



Heritage Walks to promote local heritage



The heritage walk through West Mambalam has now become an annual collaboration between Shashun Jain College and Aalayam Kanden Trust as part of the college's heritage club activities. A walk was arranged for a fresh batch of students in December 2019.

As part of the Sundaram Finance Mylapore Festival, a walk titled "Goddesses of Mylapore", featuring the lesser known female deities of Mylapore village, was conducted in January 2020.

A walk was facilitated in February 2020 for the US Consulate General and Care Earth Trust as part of the Water Matters Exhibition to Chintadripet – the walk focussing on how water was a key contributor to Madras' first planned township for weavers – Chinna Thari Pettai

Book release - Paadal Perum Paranthaman Aalayangal

To cater to the benefit of the Tamil speaking audiences and to raise awareness in them about lesser known heritage sites of Tamil Nadu, Aalayam Kanden Trust collaborated with Poet Diwakara Tanujaha to bring out a book on lesser known Vishnu temples of Tamil Nadu, complete with hymns specially written by the poet in the same format as the Prabhandhams written by the Azhwars. The book was released by Shri. Yessel Narasimhan, the world's largest collector of Carnatic Music, in the presence of Sri. Karu Nagarajan, Dean, Bharath University and Sri. G Sankaranarayanan, Professor and HOD, Department of Sanskrit and Indian Culture, SCSVMV University, Kanchipuram, apart from other dignatories. Banners with the hymns, and history of the temple with QR code to access the English articles online were provided to the temples that were covered in the book and videos of the hymns, that were beautifully rendered by Ms Vidya Devanathan, were uploaded on the Aalayam Kanden You Tube Channel.
